\$10 Registration fee per ham (limit of 2) and/or bacon (limit of 2). Max fee of \$40, if registering 2 hams & 2 bacons.

Only one item per individual may be sold at the auction. You may show hams, bacons, or animals, but only one can be sold. Once the judging of all items has been completed you will need to choose which item you want to sell. If you show more than one of the same item, the top scoring item will be the one that is sold. As voted on at the January 2005 Fair Board meeting no refunds will be made for an item that is not selling.

Conference judging is MANDATORY on Tuesday, June 9, 2026 (see Fairbook).
